AC suggested looking to the Lawshall Plan as Lawshall is a similar sized Parish to Chelmondiston. Cllr Kirkup asked about costs as there is only a small budget of around £10,000 in addition to any Grants. AC proposed three levels of costing and that he would email the Parish Clerk with the costings and a detailed proposal. That concluded Planning Directs presentation. Cllr Kirkup thanked SM and AC for their presentation.
